

PERSONAL DATA PROTECTION NOTICE

This Personal Data Protection Notice (“**Notice**”) describes how Privasia Technology Berhad and its group of companies, hereinafter collectively referred to as (“**the Privasia Group**”), use your Personal Data.

By engaging the Privasia Group to provide services or products or by using any one of the websites (“**Websites**”) of the Privasia Group, you consent to the processing of Personal Data by and all persons involved in the provision of services and products by the Privasia Group.

In the event of any conflict between the English and Bahasa Malaysia version, the English version shall prevail. The Privasia Group shall have the right to modify, update, or amend the terms of this Notice at any time by placing the updated Notice on all Websites. By continuing to communicate with the Privasia Group or by continuing to use the Privasia Group services following the modifications, updates, or amendments to this Notice shall signify your acceptance of such modifications, updates and amendments.

Collection of Personal Data

1. “**Personal Data**” means information about you, including but not limited to your name, identification number, address, telephone number, fax number, bank details, email address, your occupation, your designation in your company, your company details, the industry in which you work in and any information about you that has been or may be collected, stored, used and processed by the Privasia Group from time to time.
2. In addition to the Personal Data you provide to the Privasia Group directly (ie. during you communications with the Privasia Group and/or when you engage Privasia Group to provide services), the Privasia Group may also collect your Personal Data from a variety of sources including without any limitation to events, conferences, seminars, talks or cookies used on the Websites.
3. The provision of your Personal Data is voluntary. However if you do not provide your Personal Data, the Privasia Group will not be able to provide you the services you require or even communicate with you.

Purposes of Processing

4. The Privasia Group may use and process your Personal Data for the purposes relating to the services you have requested for and for the business activities of the Privasia Group which shall include without limitation:-
 - a) to communicate with you;
 - b) to respond to questions and comments from you;
 - c) for internal administrative purposes;
 - d) to provide information to regulatory and governmental authorities in order to comply with statutory and government requirements;
 - e) for the Privasia Group to comply with its obligations under law;

and you agree and consent to the Privasia Group using and processing your Personal Data in the manner as identified in this Notice.

Other purposes

5. The Privasia Group may also use and process your data for other purposes such as:-

- a) to distribute information or details of events, seminars and conferences which may be of interest to you;

by way of email or mail.

- 6. If you do not consent to the Privasia Group processing your Personal Data for the purposes listed in No. 4 and 5 hereinabove, please notify the Privasia Group using the contact details stated below.

Disclosure to Third Parties

- 7. The Privasia Group may engage other companies, service providers or individuals to perform functions on behalf of the Privasia Group and consequently may provide access or disclose your Personal Data to third parties such as those listed below:
 - a) information technology (IT) service providers;
 - b) any professional advisors and external auditors; and
 - c) regulatory and governmental authorities in order to comply with statutory and government requirements.

Access and Correction Requests and Inquiries

- 8. Subject to any exceptions under applicable laws, you may at any time hereafter request for access to, or for correction or rectification of your Personal Data or limit the processing of your Personal Data, or seek further information from the Privasia Group by contacting:-
